# PANELISTS

## LEWIS JOHNSON

COUNCILMAN, CITY OF GRENADA

**Lewis Johnson** was first elected to the Grenada City Council in 1988 and has also served as Vice Mayor. Johnson is a Grenada native who received higher education at Jackson State University and The University of Colorado. He is a past President of the Mississippi Black Caucus of Elected Officials, Regional Director and Treasurer of the National League of Cities Black Caucus, life member of the NAACP, Board of Directors for the World Conference of Mayors and Mason 32nd Degree. In 2008 he was inducted into the Mississippi Municipal League Hall of Fame.

He has served as President of the National Conference of Black Mayors, a Member of the US Conference of Mayors Advisory Council, and an At-large Member of the Executive Committee of the National Democratic Committee. He is a Life Member of Alpha Phi Alpha Fraternity, a Life Member of the NAACP, and a member of Sigma Pi Phi Fraternity. He is a former President of 100 Black Men of Jackson, Inc.; and he was the 2023 National Mentor of the Year for 100 Black Men of America. He is married to Kathy Ezell Johnson, and they are the parents of two children.

## DR. BERNEECE HERBERT

**Dr. Berniece S. Herbert** is a solutions-focused leader and social scientist with more than 25 years of experience across academia, government, and the nonprofit sector. 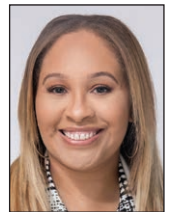
